## APPLICATION FOR A RENEWAL OF AN OFF LICENCE - INVERCARGILL LICENSING TRUST TRADING AS COLLINGWOOD BOTTLE STORE AT 44 NORTH ROAD, INVERCARGILL - 73/OFF/7184/2018

On 6 July 2018 the Invercargill District Licensing Committee received an application to renew an Off Licence for Invercargill Licensing Trust trading as COLLINGWOOD BOTTLE STORE at 44 North Road, Invercargill. The principal purpose of the premises is as a bottle store.

The Chair of the Invercargill District Licensing Committee, acting under Section 130 of the Sale and Supply of Alcohol Act 2012, considered your application on 26 October 2018.

I advise that your application has been granted under Section 133 and 135 of the Act. The renewal will commence on 27 July 2018 (provided that you continue to meet the requirements of your original licence) and will expire on 27 July 2021.

The decision to grant the licence was made because the Chairperson of the Invercargill District Licensing Committee, acting under authority delegated by the Invercargill City Council, was satisfied that the sale, supply and consumption of alcohol will be undertaken safely and responsibly, and that the harm caused by the excessive or inappropriate consumption of alcohol will be minimised. The decision was made after considering information contained in reports from the Invercargill City Council Licensing Inspector, the New Zealand Police, and the Medical Officer of Health.

Please display the licence at the principal entrance to the premises at all times so as to be easily read by people immediately outside the entrance and store the renewal in a safe place.

## Right of Appeal

You have a right to appeal the decision of the Invercargill District Licensing Committee under Sections 154 and 155 of the Act. You must give notice of an appeal within ten working days after the date on which notice of the decision is given to you.

The notice of appeal must:

- (a) Be in writing; and
- (b) Specify the grounds of appeal in sufficient detail to fully inform the Invercargill District Licensing Committee and other parties of the issues in the appeal; and
- (c) Be sent to the Secretary of the Invercargill District Licensing Committee; and
- (d) Be accompanied by the prescribed fee.

## DECISION UNDER SECTION 131 and 135 OF THE SALE AND SUPPLY OF ALCOHOL ACT 2012

- That a renewal of the licence is granted. This decision is made after considering information contained in reports from the Invercargill City Council Licensing Inspector, the New Zealand Police and the Medical Officer of Health. I am satisfied that the sale, supply and consumption of alcohol will be undertaken safely and responsibly, and that the harm caused by the excessive or inappropriate consumption of alcohol will be inimized.
- That the decision on the application is deferred until further information or advice is sought and supplied.

That the application be referred to the Invercargill District Licensing Committee Hearings Panel for a decision.
